6. No gun or any weapons shall be allowed into the school premises
7. Foul language and theft shall not be tolerated no matter what circumstances
8. Learners must respect their educators and school prefects at all times
9. All students shall be expected to have a high level of discipline at all times
10. English shall be the medium of communication
11. Gender and Race equality shall be observed and hence no student shall be discriminated against gender, race or religion
